AFMS Rockhounds "Code of Ethics"

I will respect both private and public property and will do no collecting on privately owned land without permission from the owner.

I will keep informed on all laws, regulations or rules governing collecting on public lands and will observe them.

I will, to the best of my ability, ascertain the boundary lines of property on which I plan to collect.

I will use no firearms or blasting material in collecting areas.

I will cause no willful damage to property of any kind such as fences, signs, buildings, etc.

I will leave all gates as found.

I will build fires only in designated or safe places and will be certain they are completely extinguished before leaving the area.

I will discard no burning material - matches, cigarettes, etc.

I will fill all excavation holes which may be dangerous to livestock.

I will not contaminate wells, creeks, or other water supplies.

I will cause no willful damage to collecting material and will take home only what I can reasonably use.

I will practice conservation and undertake to utilize fully and well the materials I have collected and will recycle my surplus for the pleasure and benefit of others.

I will support the rockhound project H.E.L.P. (Help Eliminate Litter Please) and will leave all collecting areas devoid of litter, regardless of how found.

I will cooperate with field-trip leaders and those in designated authority in all collecting areas.

I will report to my club or federation officers, Bureau of Land Management or other authorities, any deposit of petrified wood or other materials

on public lands which should be protected for the enjoyment of future generations for public educational and scientific purposes.

I will appreciate and protect our heritage of natural resources.

I will observe the "Golden Rule", will use Good Outdoor Manners and will at all times conduct myself in a manner which will add to the stature and Public Image of Rockhounds everywhere.

Mike wants to double check with Elmer about Vincent or Vinegar Creek on the Middle Fork before making final plans for the Middle Fork area. The dates will be solidified when we are closer to the time listed on the calendar. We also discussed the fact we should be having members sign a field trip waiver. Know Your Federation – Junior Achievement

To break it down; our current Junior Chairperson is Gayle Butler. The Federation has a trust fund that is strictly for Junior members. This fund is used to award Junior members for their efforts. There is an application form that will need to be turned in by a certain date. There is a list of criteria which asks about achievements the Junior member has accomplished in school, personal life and rockhounding the last two years. The form is somewhat of an essay form. Junior members submit that to the Junior Achievement Chairperson and wait to be notified if they have won an award. Any Junior is eligible. Alex Lopez won a small cash award a few years ago and Tatyana Coronell won a certificate this last year. The idea of this award is to help encourage our Future Rockhounds of America and acknowledge them for what they do. I hope to see some entries this year.



Exciting New Discoveries A mineral show is a great place to see specimens that you have never seen before. The shapes and colors of minerals are always amazing! Here is a specimen that is unique, and which, according to the dealer, is a brand new discovery that is just now available for collectors. This is an unusual specimen. It was discovered in Minas Gerais, Brazil (a region of the world that has produced world-class mineral specimens for many, many decades). When the miners opened up the pocket that held these crystals, they expected to find very, very large tourmaline crystals. If they were tourmalines, they could be gemmy and worth a lot of money, especially if they were cut and polished to make gemstones. They were disappointed, however, to discover that all of the tourmaline crystals had

changed into muscovite mica! This is called a "pseudomorph." Pseudomorph means false form. In other words, it has the form of tourmaline but it has turned into muscovite. How does this happen? After the tourmaline forms, there is a change in the chemistry of the hot waters that filled the hole (geologists call this a "vug") where the tourmaline grew. Because the chemistry

changed, the tourmaline was transformed into muscovite. Look carefully at this picture.

You can see the tourmaline form (long, thick crystal) but what you are looking at are thousands of small muscovite crystals. The dealer said this is a "one-of-a-kind" discovery and that he had the only specimens for sale. Sometimes this is true; sometimes the dealer is trying to get you to buy the specimen, so he makes it sound more exciting. So, if you want to have one for your collection, you better buy it while you can, or you may never have a chance to buy one like it ever again. In the end, I didn't buy one...they were too big for my collection. But they sure are interesting!!
