# AFMS Rockhounds "Code of Ethics"

I will respect both private and public property and will do no collecting on privately owned land without permission from the owner.

I will keep informed on all laws, regulations or rules governing collecting on public lands and will observe them.

- I will, to the best of my ability, ascertain the boundary lines of property on which I plan to collect.
- I will use no firearms or blasting material in collecting areas.
- I will cause no willful damage to property of any kind such as fences, signs, buildings, etc.

I will leave all gates as found.

I will build fires only in designated or safe places and will be certain they are completely extinguished before leaving the area.

I will discard no burning material - matches, cigarettes, etc.

I will fill all excavation holes which may be dangerous to livestock.

I will not contaminate wells, creeks, or other water supplies.

I will cause no willful damage to collecting material and will take home only what I can reasonably use. I will practice conservation and undertake to utilize fully and well the materials I have collected and will recycle my surplus for the pleasure and benefit of others.

I will support the rockhound project H.E.L.P. (Help Eliminate Litter Please) and will leave all collecting areas devoid of litter, regardless of how found.

I will cooperate with field-trip leaders and those in designated authority in all collecting areas.

I will report to my club or federation officers, Bureau of Land Management or other authorities, any deposit of petrified wood or other materials

on public lands which should be protected for the enjoyment of future generations for public educational and scientific purposes.

I will appreciate and protect our heritage of natural resources.

I will observe the "Golden Rule", will use Good Outdoor Manners and will at all times conduct myself in a manner which will add to the stature and Public Image of Rockhounds everywhere.

#### Hatrockhounds Gem and Mineral Society Minutes General Meeting January 9, 2024

President, Doug, called the meeting to order and asked for an account from the treasurer. Mel gave a report of the money that was in the account after paying Federation dues, Oregon Council dues, Post Office and a donation to the church. NOTE: If dues are not paid by the end of March, your name will be removed from the list and you will not receive a Gazette until dues are paid. Doug then asked for any old business. Judi explained that

we want to keep the show account separate from the regular treasury, as we need to make a thorough accounting to the Federation after the show so we can show that we are dividing the profits. Doug then appointed Judi Allison the official Treasurer for the show. She will keep all show money accounted for and make deposits and disbursements from a special account which will be closed after payment to the Federation with the balance going into the regular Hatrockhounds account.

The possibility of a raffle for the show was suggested. We would need to have some donations of some quality items in order to do such. Tickets could be sold for a specified amount and the prized could be given out at the end of the show. Mike will consider the possibility. He said the show progress is pretty much the same as last year. He is working on the contracts and floor plan.

New Business: Mel said he had tried to reserve the McKenzie Park for the picnic, but was told that it couldn't be reserved prior to a certain time. It was brought up that we had considered trying to have the picnic at West Park in Umatilla-the one on the flat down the road from the fish ladders. One should be able to reserve it through the Corp of Engineers. Mel will check into that.

Announcements: Karli asked if anyone had cabbing machines who could finish some cabs she has been cutting out with a core drill to sue as covers for pop sockets. She also asked if anyone had a 3-D printer besides Mike Zinski. Jonnie suggested she ask Barbie in the Tri-Cities Club. Karli let the membership know that she is setting up the Kids' Corner with specific prizes for specific activities, and that each activity will have a separate person running it. She stated we need lots of polished rocks. If people can polish and/or donate. Todd Adams said he has a lot of agates from the Willamette River area and will donate some. Mike mentioned that there are a lot of slabs in the trailer that could be polished. Show and Tell: Mike picked up rocks from around Cave Creek, Arizona when he went on his trip last

Present: Doug Gill, Mike Filarski, Mel Lambert, Louise Lambert, Judi Allison, Jessica Millard Mel brought up a couple of items to start off the meeting. He said he had gotten the check for the Post Office back as the amount was incorrect. It has gone up to \$200 a year. He will take a new check in tomorrow and hope we don't lose our box, since the cutoff date is the 31<sup>st</sup>. He also stated that the West Park in Umatilla has a rental fee of \$70 for the day and we can't reserve it until later. After some discussions of alternative ideas, it was decided to go ahead and reserve McKenzie Park as usual. The picnic will be on Saturday, August 17<sup>th</sup>.

Judi shared a resolution that will be brought up at the Federation meeting and asked that the club sponsor it. She got the signatures needed from Doug, as President and Jessica, as Secretary to put it forward. Show Discussion:

#### **RESOLUTION ADDRESSING THE NEED FOR MORE TIMELY, CLEARER COMMUNICATION WITHIN The Northwest Federation of Mineralogical Societies (NFMS) BY-LAWS AND OPERATION PROCEDURES**

Given the modern day ability to reach the membership rapidly and efficiently through electronic means and having become aware of many gaps in communication, Hatrockhounds Gem and Mineral Society proposes to amend the by-laws and operation procedures to streamline the process of communication with NFMS Membership.

**Proposal:** Combine Standing Committees: Circulation and Directory. Rewrite Operation Procedures to reflect current times and utilization of modern technology.

**Current Bylaws:** Article X Committees Section 2. Standing Committees (a)

Standing Committees shall be: Budget, Bulletin Aids, Circulation, Credentials, Custodian,

Directory. . .

**Proposal:** Combine wording of Circulation and Directory with a slash, to read as shown:

#### **Circulation/Directory**

Current Operation Procedures: Under OP COMMITTEE

Circulation Shall:

\*Manage list of member households

\*Provide data for "mailing labels" to the firm who mails the Northwest Newsletter.

\*Update mailing information from annual club membership lists from Directory Chair.

\*Update by deleting and adding members' information received from the individual clubs during the calendar year.

\*As needed, use a service to obtain correct address data when US Postal Service sends a "not deliverable as addressed".

\*Submit a financial report to the NFMS Treasurer.

Directory shall:

\*Under the direction of the Executive Secretary, Publish the annual NFMS Membership Directory, to be available by Mid-Year Meetings, listing NFMS Membership names, addresses, and telephone numbers as of January 1<sup>st</sup> of that year.

\*Under the direction of the treasurer, request of each membership Society, by November 20<sup>th</sup> each year, a list of the names, addresses and phone numbers of the officers and members, said list to be of paid up members as of December 31<sup>st</sup>. The list to be mailed to the NFMS Treasurer by January 10<sup>th</sup> of the following year.

\*Maintain the official, complete list of the NFMS memberships.

\*Coordinate with the Treasurer, Secretary, Newsletter and such others as might have need of the list of the NFMS members.

\*Under the direction of the Executive Secretary, maintain the official copy of the By-Laws and Operating Procedures, which are officially published in the NFMS Membership Directory.

\*Submit a financial report to the Treasurer.

\*Distribution of the Directories shall be under the direction of the Supplies Chairman.

## Change to Read: CIRCULATION/DIRECTORY

- Shall With coordination from the Treasurer, Secretary, Newsletter and such others as might have need manage and maintain a current membership list for each member society.
- With coordination from the Treasurer and Secretary, request of each member Society, by November 20<sup>th</sup> of each year, a current list of members, including contact information for all officers and a viable, stable electronic contact for each club. (This contact to be used for dissemination of information relative to all business of the Federation.) Share the list with the NFMS Treasurer to be used in requesting yearly Federation Dues.

- From such list, update and maintain an official, complete list of the NFMS memberships.
- Maintain a household mailing list of members in clubs that opt to receive the Newsletter via hard copy.
- Maintain data for "mailing labels" of households in clubs that opt to receive the Newsletter via hard copy, to be provided to the firm that mails the hard copies of the Newsletter.
- As needed, use a service to obtain correct address data when US Postal Service sends a "not deliverable as addressed."
- From the membership information gathered, create an Annual NFMS Membership Directory via Word Doc to be delivered electronically to each NFMS Member Club by April 30th. With coordination from Secretary and Treasurer, assure that copies are sent to each Member Society. (Hard copies can be provided upon request, if needed.)
- Directory will include Society name, meeting information, mailing address, stable electronic contact address, names and contacts for all officers and a listing of all members. (Current By-laws and Slide/Video Library can be found on the NFMS Website and are updated and maintained by the Secretary and Library Chairperson.)
- Submit a financial report to the Treasurer.
